I sit here thinking about my first born daughter Savanna Greywind. I miss her laugh and smile. We all miss her oh so much.

I would hear people say that the pain of losing a child is like no other pain. I know that pain. My heart is literally broken.

I find myself looking through pictures and videos of her and all the people she loved. I get so upset and angry and can't understand how and why these people could take my girl from us.

Brooke Crews befriended us. She would come into the store where I worked. It seems odd now because that is the only time I would see her or talk to her. Also when we were at work on a few occasions she would knock on my door. I can only assume NOW that she was motoring our daily routine.

They day my daughter went upstairs to help that woman I knew something wasn't right, and that this woman had done something to my daughter. I begged her to please let me look in her apartment so I could focus on other places to look for my daughter. She refused, of course, and screamed at me saying "I have no more sympathy for you Mrs. Greywind". Then she called the cops on us. I was then absolutely positive that this woman had done something to my girl.

The nightmares are horrific! I dream that I'm still looking for my daughter and cannot accept that someone could have done this to her. I think about the pain she went through and how scared she was.

I have so much guilt. I'm her mother and I feel that I should have been able to protect her. Io know that I couldn't have known that that woman would have hurt my girl but every day I wonder if my daughter tried to scream for me. For someone to do that to any human is beyond evil!!

We had to move out of the Fargo Moorhead area because our trust and safety and security was completely violated. We as a family go to therapy. We miss Savanna so much.

The most painful part of all this is that Haisley Jo will never have the amazing relationships/ bond and memories with her mother like Savanna and I had. I hold Haisley Jo and I just think of how Savanna would have been with her. She would have been an amazing mother. Oh how I miss my girl!

I think of the conversations we had throughout her pregnancy and the planning and excitement we all had. She would make lists of everything she needed for Haisley. We were planning for a baby shower on August 20th. I wanted and was trying to convince her to let me mold her tummy and we never got that chance.

I babied my girl even more so while she was pregnant. We talked about who would be with her and the roles we would all have during her delivery. We were all so excited that my girl was going to be a mommy and a wonderful one she would have been. That was all taken from every one of us! Savanna was taken from her daughter, Haisley Jo, in such a horrific way. The pain and that void my granddaughter will live with for the rest of her life just breaks my heart to pieces.

I do not feel that there is court sentence that will ever be strong enough. My daughter is gone forever! Savanna will never experience motherhood and watch her daughter grow. Haisley's first tooth, first steps and first words is something a parent, a mother, is so proud of. Haisley will never have that. We only have our memories to share with Savanna's daughter. That is it! My granddaughter's life without her mother, who loved her with all her heart since the moment she learned she was pregnant, is forever going to affect her! This is so very senseless and cruel!
