Statement of Beth Ferrier

In the mid-80s, I was an aspiring model and actress when I met Bill Cosby in New York City through my then-agent. Mr. Cosby pursued me and we ended up having an extramarital affair for several months. A few weeks after I ended things with him, he called me and told me that he was coming to Denver, Colorado, where I resided at the time, to perform at a now-defunct club. I went at his request to see his performance. When I arrived backstage, Mr. Cosby greeted me and handed me a cappuccino, telling me that he had made me "my favorite coffee." After I drank it, I felt dizzy and lost consciousness. The next thing I knew, hours had passed, and I woke up in the back of my car alone. My clothes were a mess; my bra was undone. My car was in the alleyway behind the venue. I felt confused and disoriented. I had no idea what happened to me. The last memory I had was drinking Mr. Cosby's coffee.

Two security guards approached me in my car and told me that Mr. Cosby had told them to get me home. One of them drove me to my house because I was still feeling woozy. After I arrived home, I gathered my senses and drove to Mr. Cosby's hotel to confront him about the night's events. Mr. Cosby's explanation for what happened was that "[I] had too much to drink." I did not believe him. I had not consumed any alcohol that night. I believe that Mr. Cosby drugged me in order to sexually assault me that night.

For years, I did not tell anyone about what he had done to me because I was afraid. I felt threatened by him and I did not think anyone would believe me.

In 2005, when I saw a National Enquirer story that another woman, Andrea Constand, had filed a lawsuit against Mr. Cosby alleging that he drugged her and molested her, I wanted to come forward with what Mr. Cosby had done to me too. I called the National Enquirer and told them that I believed Mr. Cosby had drugged and sexually assaulted me. The National Enquirer told me that they would only publish my story if I took a lie-detector test. I did and I passed it. To my surprise, the

National Enquirer did not publish my interview and instead ran an exclusive interview with Mr. Cosby where he denied all the allegations, stating that "sometimes you try to help people and it backfires on you, and then they try to take advantage of you."

I became Jane Doe No. 5 in Ms. Constand's lawsuit. I received such fierce backlash when I came forward in 2005 that I had to change my number several times and lost relationships with my family and friends. I have recently learned that Mr. Cosby admitted in his deposition in 2005 that he did not want the National Enquirer to publish my story because "it would make the public believe that maybe Andrea was also telling the truth." If Mr. Cosby would accept Gloria Allred's proposal, I would be able to have my day in court. I want Mr. Cosby to face justice for what he has done to me and so many other women. I hope my coming forward inspires any other person harmed by Mr. Cosby to have the courage to come forward and tell the truth about what happened. Thank you.

Statement of Chelan

In 1986 I was working at the Las Vegas Hilton while I was in high school. I was 17 years old and an aspiring model. I was working at the Hilton as a bell dispatcher at the bell desk. My father was married at the time and his wife wrote a letter and sent pictures of me to Bill Cosby.

Bill Cosby called me at home in Las Vegas and reached my grandmother. He said he wanted to meet me and that my grandmother and I should come to the Hilton Las Vegas where he was going to be performing his show. He said to meet him in the Elvis Presley suite. He was going to introduce me to someone from the Ford modeling agency.

I had a cold at the time so he gave me a blue pill, which he said was an antihistamine, with a double shot of Ameretto. He was rubbing my neck and saying that he might have to have someone come in to give me stress therapy. He had me put on a Hilton robe because he said someone from the Ford agency was coming up to the suite and that I should wet my hair so that they could see the texture of my hair. Someone did come into the room, took a couple of pictures and told me to lose 10 pounds. Then they left.

Then Mr. Cosby walked me to the bedroom after a second shot of Ameretto. He said it would help with my cold. I laid down. He laid down next to me on the bed and began pinching my left nipple and humping my leg while he was grunting.

I could not open my eyes. I couldn't move or say anything. I felt something warm on my legs. Then I blacked out.

13 to 16 hours later I woke up by hearing Mr. Cosby clapping his hands and saying "Daddy says wake up". He gave me \$1500. He said the money was to buy something nice for me and my grandmother and he also invited me to go to the Temptations show with my grandmother. My grandmother went but I did not go because I felt too sick. Then he invited us to his show. My grandmother really wanted to go. I did not, but I went with her and heckled him. As a result I was fired from my job.

Statement of Helen Hayes

My name is Helen Hayes. I want people to know that I had an encounter with Bill Cosby in the summer of 1973. I was attending Clint Eastwood's Celebrity Tennis Tournament in Pebble Beach, CA with two of my friends. Bill followed us around all day on Saturday. He found us again on Saturday night, even though we had changed restaurants several times to avoid him. At first we thought it was alright because it was daytime and it was Bill Cosby. We felt we were safe. But then when he found us in the last restaurant he approached me from behind and reached over my shoulder and grabbed my right breast. I was stunned and angry because he had no right to do that and I did not know why he would behave that way. His behavior was like that of a predator.
