## **Statement of Gloria Allred**

Today we are here to challenge Herschel Walker to meet with our client, Jane Doe, the woman that he said recently he did not know even though he had a romantic relationship with her for six years, caused her to become pregnant, and then pressured her to have an abortion even though she wanted to have their baby.

My client, Jane Doe, and I held a press conference on October 26, 2022, during which she shared that she and Herschel Walker were in a romantic and intimate relationship from 1987 to 1993.

In May of 1993, she learned that Mr. Walker had impregnated her. My client did not want to have an abortion. When she told Mr. Walker about the pregnancy, he spoke about disappearing and the “after life” and made her believe that he might commit suicide. He also claimed that if she gave birth, both our client and their child would be in danger.

Jane Doe stated that she felt pressured by Mr. Walker's threats and went alone to the abortion clinic to have the procedure but left crying because she did not want to go through with it. After she told Mr. Walker that she did not have the abortion, she stated that the next day, Mr. Walker drove her in his car to the abortion clinic to ensure that she had the abortion that she did not want to have.

In response to our press conference, and the documentary evidence which Jane Doe produced at the press conference, Mr. Walker said that it was all a "lie." He refused to acknowledge any relationship with Jane Doe or even that he knew her.

***"Brett Baier: All right, this was Gloria Allred came forward with this client. You're saying you don't know this person?"***

***Herschel Walker: What I'm saying this is a lie."***

Herschel Walker also released the following press statement on his webpage on November 1, 2022, reiterating that he did not know our client, Jane Doe:

***“This was a lie a week ago and it is a lie today. Seven days before an election, the Democrats trot out Gloria Allred and some woman I do not know.”***

We have overwhelming evidence which supports the relationship between my client and Herschel Walker including letters, audio recordings, diaries, cards, notes, photos, and a declaration from a friend.

We are here today to challenge Mr. Walker. Mr. Walker, do you have the courage to meet with Jane Doe, look her in the eye and tell her that you do not know her, that you never told her how much you loved her; that you never met with her parents or wrote them a letter in your own handwriting in April, 1993; that you did not make phone calls to her telling her how much you loved her when you were at the Olympics in 1992?

Mr. Walker, do you deny that it is your voice on the following audio recordings?

**TRANSCRIPT OF HERSCHEL WALKER’S VOICE MESSAGE**

*“Ah, you. This is your ‘stud farm’ calling you big sex puppy you. Can't believe you're not in. I will, ah, talk to you later. You be sweet. Bye bye.”*

Here is another recording of you, Mr. Walker, speaking to Jane Doe, the woman that you say you don’t know:

## **TRANSCRIPT OF RECORDING:**

***Jane Doe:***

*OK, OK well have a good day today.*

***Herschel Walker:***

*Thank you and I love you.*

***Jane Doe:***

*I love you very much.*

***Herschel Walker:***

*I love you now.*

***Jane Doe:***

*And I love you more. No call me. You said your race is Saturday morning, right?*

***Herschel Walker:***

*Yeah, Saturday morning.*

***Jane Doe:***

*OK, so will you call me back and tell me how it went?*

***Herschel Walker:***

*Yes, I'll do that.*

***Jane Doe:***

*I'm going to stay right here by the phone until I hear from you.*

***Herschel Walker:***

*OK.*

***Jane Doe:***

*Well, I'll probably be sleeping right here by the phone until I hear from you.*

***Herschel Walker:***

*OK, I will call.*

***Jane Doe:***

*OK, I love you baby.*

**Herschel Walker:**

Love you too.

**Jane Doe:**

OK thanks. Bye.

Mr. Walker, in addition to Jane Doe's statement, we have a signed declaration under penalty of perjury from her friend stating the following:

*"In the spring of 1993, "Jane Doe" confided to me that she was pregnant, and that Mr. Walker had impregnated her. I was with "Ms. Doe" when she took two consecutive pregnancy tests and I saw her positive test results. "Ms. Doe" was shocked to learn that she was pregnant because she told me that she was on birth control. I could visibly see how upset "Ms. Doe" was by her facial expression and the tone of her voice.*

*About a month later, "Ms. Doe" told me that she had a "miscarriage." However, I suspected that "Ms. Doe" had had an abortion because Mr. Walker did not want her to continue with the pregnancy since he was still married at the time.*

*Shortly thereafter, "Ms. Doe" abruptly left Dallas. I was surprised because "Ms. Doe" had never indicated that she had any plans to leave, and I knew that she loved her job. "Ms. Doe" was very upset and told me that she was leaving Dallas to go home to be with her family for support. "Ms. Doe" also told me that she was very upset with Mr. Walker and that she had broken off their romantic relationship.*

*Several years after “Ms. Doe” abruptly left Dallas, she confessed to me that she had, in fact, had an abortion in 1993 as I suspected. “Ms. Doe” also told me that Mr. Walker had personally driven her to the clinic to obtain an abortion.”*

Mr. Walker, you were a big-time football player, and now you want to be a United States Senator. I challenge you to meet with Jane Doe and me in a public place in Georgia, at a time and date of your choosing prior to December 6 to respond to the evidence that we have presented today and at our previous press conference about your relationship with Jane Doe. Feel free to bring any evidence you have that contradicts our evidence.

If you don't agree to accept our challenge and to meet our client in person prior to December 6, 2022, we think it is fair for the voters in Georgia to conclude that Jane Doe is telling the truth and that you are not being transparent and honest with the voters in Georgia.
